What accomplishments/progress has your Affiliate made in the past year? (Consider member resources, awards and recognition, public affairs, etc.)

Ohio Affiliate NEAFCS members, Kate Shumaker and Pat Brinkman, served their first years as national Secretary and Vice President Professional Development, respectively.

Ohio was well-represented on at least 14 national committees and continues to serve as award reviewers, peer proposal reviewers, and as volunteers at Annual Session.

NEAFCS members took leadership in the state of Ohio in the following programs: Trauma Informed Care Approaches trainings, Level 2 and Level 1 Food Safety instruction, online Successful Co-Parenting, Live Healthy Live Well E-mail challenges, Live Healthy Live Well 365 text messages, Your Plan for Health Programming, virtual ZUMBA and other wellness classes, Farm Stress webinars, and continued collaboration with local, state, and national agencies and organizations.

Cheryl Spires represented Ohio at the Virtual Joint Council of Extension Professionals Conference in February 2021.

Tammy Jones represented Ohio at the Public Issues Leadership Development Forum (PILD) in that was held virtually in April 2021.

Impact reports were completed by Ohio members and then compiled by Brian Butler FCS Program Evaluation Director, with assistance from OSU Extension Evaluation staff and sent to NEAFCS VP of Public Affairs.

Sixteen awards were submitted from Ohio NEAFCS members for individual or team NEAFCS awards to Regional Judging. At the 2021 NEAFCS Virtual Annual Session, Ohio received 2 National Awards and 9 Regional Awards along with 1 Distinguished Service Award and 2 Continued Excellence Awards.
