In May, our affiliate board met again to plan for an affiliate business meeting. The 'Spring' affiliate business meeting was held via Zoom on June 5.

In August, our affiliate assisted our colleagues in the National Association of County Agricultural Agents (NACAA) to host national attendees at their annual conference in Des Moines, Iowa.

Many great accomplishments coincided with the 2023 NEAFCS Annual Session in September. 17 affiliate members and one lifetime member traveled from Iowa to Providence, Rhode Island.
