What accomplishments/progress has your Affiliate made in the past year? (Consider member resources, awards and recognition, public affairs, etc.)

- Membership was opened to the new category of Associate members, we had 3 individuals sign up to become associate members. We currently have 121 members across the state of Tennessee.
- Tennessee had 66 award submissions this year with 15 being Southern Region winners and 12 of these rising to the National level.
- Annette Cole attended JCEP in February
- Elizabeth Renfro & Annette Cole represented TEAFCS at PILD in April
- We held our State Conference in Nashville, TN with our Central Region Affiliate hosting us.
- Began utilizing the Endowment Funds we have set-up in TN to support our association. More specifically for awards. The Endowment and Expenditures Committee is working on how we can best utilize and help support the members and efforts of TEAFCS.
- TEAFCS updated our by-laws to align with NEAFCS By-Laws. As well as updated our Statement of Policy
- Part of our by-laws we combined membership due payment into one to make it easier and less confusing for members. The membership dues include those for national, state, and region and sent to the state treasurer. The state treasurer would then cut a check to the region treasurers to put into the region treasury.
- Tennessee had 25 members attend National Conference in Providence, RI.
- Elizabeth Renfro, submitted a bid for NEAFCS Annual Session to be held in TN in 2026. The bid was accepted and approved to be held in Knoxville, TN.
- Tri-Liaisons are currently being identified to represent TN for the National Session.
- We concluded the year with a Transitional Board Meeting in Murfreesboro, TN where new officers were initiated and all could meet to learn about their respected new roles.
